#### 5. BUSINESS ARISING FROM MINUTES

5.1 OPP Communications Portal - Registration of PSB Members
Brent Kittmer updated the Board that an email was sent regarding the registration of PSB members.

5.2 Report Out: Focused Patrol on Speeding (fines issued, Speed Spy reports, etc.)

Staff Sergeant Stephane Pilon clarified the use of the Speed Spy to measure the probability of a speeding issue in a particular area. The 85th percentile speed is the warrant to determine if a focused patrol is required.

Speed enforcement along James Street South and Queen Street has resulted in 43.5 hours of enforcement and 6 POA notices.

Officer McLeod has been enforcing at the crosswalks at DCVI.

Speed Spy was deployed in October with the likelihood of redeployment in the future. The OPP will continue to monitor the issue.

5.3 Discussion - Definition of a "Call for Service" for the School Resources Officer

Inspector Rob Scott clarified what a CFS at high school entails. A CFS occurs when Officer McLeod takes action and has to make a report and / or an action that causes police action at the school.

CFS is not involved when an informal response such as education of students, discussions, or actions to prevent a situation, for example when the Officer consults with the school on matters, issues, and sharing of information.

7.1 OPP Monthly Statistics (January 2017)

Inspector Rob Scott spoke to the report.

Board Member DeYoung inquired about the value of Crime Stoppers.

Inspector Scott stated that the program has been restructured internally so that it is a duty covered off by an officer as a part of other duties. There is no longer one officer fully dedicated to the program. Additionally, there are more policing duties, analytics, and community services on that officer.

Chair Van Galen cited a recent vehicle recovery that took place at Canadian Tire parking lot and inquired if it normally takes 6 months for recovery.

Inspector Scott stated that it does happen as the police do not review every plate on every vehicle. The police rely on reports from citizens.

8.1 Ms. Cole Atlin re: Request City of Stratford to Hire a Third Party to investigate "Unfounded" Sexual Assault Statistics

Inspector Scott will confirm the detachment's statistics regarding unfounded sexual assault. An OPP review will be completed provincewide. Inspector Scott will report back on further details of how the review is being completed.

It has been confirmed that the Province is undertaking a review at the corporate level of this situation.

An unfounded sexual assault means that there is sufficient information to believe a crime does not / did not exist. An issue with the unfounded

statistics is that the reporting system does not provide the breadth of options to categorize how a crime is cleared. "Unfounded" does not necessarily mean that a victim's claim is dismissed. The OPP take all statements at face value, and investigate in an attempt to substantiate the report. Many that are investigated are cleared as "unfounded".

POA fines were generated through other agencies as well (ie: MOE, MOL, MTO).
