EDAC Members discussed that the St. Marys market niche and vision for the economy needs to be defined before making decisions on an approach, marketing, and other specific tactics.

EDAC Members commented that the issues of finding employees for local businesses, having a range of housing types at various costs, and having serviced land for industrial and/or commercial development are three things that are impacting the growth of the local economy and that this is consistent in many areas in Ontario and beyond.

Laurel Davies Snyder described the proposed changes to the OLH website which will include: better mapping, faster connections, and a business directory. The County of Perth is spearheading these proposals.
