6.1 COR 05-2018 Cadzow Park Splash Pad Design Review

The Committee discussed the Cadzow Park Splash Pad design.

The Committee suggests to the project staff that firm and stable paths of travel be included at Cadzow Park leading visitors from the parking lot to each amenity and between each amenity to ensure caregivers have a more direct path of access to their dependents.

The Committee suggests to the project staff that a more significant colour contrast can be implemented between the sand stone / surf stones and the floor surface.

The Committee suggests to the project staff that signage be implemented at the site to clearly define how to activate the system.

The Committee suggests to the project staff that the painted frog and snake not be included in the design due to the increased possibility of the paint's deterioration.

The Committee suggests to the project staff that confirmation be received from the proponent that the drain grates not be made of a metal product that does not heat up due to the sun's rays.
